As you pull in you are greeted by a gorgeous bird's eye view of the property and the rolling hills of beautiful western Stewart County GA. Driving in a little further you have twin peaks towards your left with elevations of 470' and 460', and a nice creek bottom with an elevation of 360'. To your right is another great view across the property and down to a nice creek bottom and well located food plot at an elevation of 300'. If rolling topography and great views and long range hunting opportunities interest you, you need to come see this gorgeous property. \pm 153 acres have been recently clearcut and is naturally regenerating in hardwoods and pine. There are two nice creek bottoms with gorgeous mature oaks and mixed hardwood with three clear running creeks.
